

EXHIBITOR BUSINESS NAME

1) ACCESS TO THE EXHIBITION CENTER

The Exhibition Center is open on the days and times established by the Organizer: the relevant indications will be made known to exhibitors and visitors with the means that BolognaFiere deems most suitable for the purpose.

Opening days and times may however be changed at any time, subject to simple communication, also by means of loud speaking systems, carried out inside the Exhibition Center or at its accesses.

Access to the Exhibition Center will be allowed only to persons legitimately equipped with the regular entry document, a document which must be kept during the entire period of stay in the Exhibition Center and which must be shown at every request of the service staff in the Exhibition Center.

2) OBLIGATIONS AND REQUIREMENTS

Those who enter the Exhibition Center are required to maintain a civil behaviour in respect of the goods and equipment of both BolognaFiere and third parties present in the Exhibition Center and to promptly and scrupulously observe the prescriptions and provisions issued by BolognaFiere to the entrance and inside the District with specific signs, with written notices, with press releases circulated through the loudspeaker system, as well as through the service personnel and by any other means, with the specification that the loudspeaker press releases and the instructions given by the staff of service prevail over other notices.

3) SPECIFIC PROHIBITIONS

It is forbidden for anyone to carry out promotional or marketing actions outside the stands and without written authorization from the Organizer

It is forbidden for anyone to promote, within the Exhibition Center, offers, bids and donations for institutions of any kind, to carry out religious, political or trade union activities, and any and all activities not related to the purposes of the current Exhibition.

In particular, it is clearly forbidden to organize and participate in games of skill and chance for any purpose promoted.

Access to the Exhibition Center is normally forbidden to minors under the age of 14, even if accompanied: any exceptions may be arranged by BolognaFiere for each individual Exhibition and communicated to the public by the means deemed most suitable.

The entry of dogs is allowed only if on a leash and equipped with a muzzle

or with a special container, except for dogs for disabled people who can access without limitations.

The movement of anyone in the District by mechanical means such as roller skates, scooters, bicycles or mopeds is prohibited, with the exception of the BolognaFiere service staff or the Organizer.

It is forbidden to use, for any purpose, drones inside the Exhibition Center. It is forbidden to enter the Exhibition Center with cameras, video recorders and any other kind of recording equipment without the prior authorization of BolognaFiere and it is forbidden to photograph and shoot the Interior of the Exhibition Center, stands and goods displayed without any means the prior consent of BolognaFiere and the stand owner.

BolognaFiere may prohibit entry to the Exhibition Center or to individual pavilions with bags, suitcases or other containers, prescribing their storage in the cloakroom.

Offenders may be removed out by the service staff.

4) VEHICLES ACCESS

Access will be allowed, through the authorized driveways, only to vehicles equipped with a specific authorization and to people who are on them, provided they have the entry document. Parking of vehicles inside the Exhibition Center will be allowed only in the appropriate spaces (with display of the vehicle access document) and no later than the closing time of the Exhibition Center. In particular, it is not allowed to unload and park containers or detachable parts of non-self-propelled vehicles. In the event of non-compliance with the aforementioned provisions, BolognaFiere or the Organizer may remove the vehicle from the Exhibition Center, at the risk and expense of the exhibitor to whom the badge was issued and of the owner of the vehicle who will remain jointly and severally liable with the exhibitor for the related expenses. BolognaFiere is exempt from any responsibility for the safekeeping of the vehicle and will not be responsible for damages and thefts of any kind.

For safety reasons, during the days of opening to the public, access and parking in the Exhibition Center will be allowed only for cars (therefore, all different means such as commercial vehicles, trucks, etc. are excluded). In violation of this provision, BolognaFiere may take steps to obtain the forced removal of the vehicle from the parking lot, or the fixing mechanical tools that inhibit its use at the risk and expense of the owners.

5) FACULTY OF INTEGRATIONS AND DEROGATIONS

BolognaFiere has the right to integrate, modify and cancel these provisions and to derogate from them, by giving notice in the ways deemed most suitable.

6) SANCTIONS

Failure to comply with the obligations established in these regulations may result in the withdrawal of the entry documents and the immediate removal of the responsible persons from the Exhibition Center, as well as - if they are exhibitors or their collaborators - the temporary or permanent closure of the stand.
